TERMS AND CONDITIONS

- 3. For those staying less than a week, the full balance, together with a damages deposit of £200, is due at the time of booking.
- 4. The balance of the rent, together with the damages deposit of £200, is payable not less than eight weeks before the start of the rental period. If payment is not received by the due date, we reserve the right to treat this non-payment as a cancellation.
